

ONSTED VILLAGE PARK BALL DIAMOND(S) AGREEMENT

This agreement is entered into this _____ day of _____, 201____ by and between The Village of Onsted and_____.

Permission to use the ball diamond(s), located inthe Village of Onsted parks system is granted subject to acceptance of the following conditions:

1. The OCRC league will supersede all usages.
2. Fees may NOT be charged unless authorized by the Village of OnstedParks Committee.
3. **FEES (Excluding OCRC teams)**
 - a. **Ball fields = \$25.00 per day.**
4. The Village of Onsted does NOT furnish bases or any other equipment or supplies.
5. The user is responsible for clean up of all litter in the park area. (Including under, on, and around bleachers, dugouts or any other area used the organization's patrons) Any cleanup doneby the Public Works Department may be charged to the user with a one-hour minimum charge.
6. Teams shall rake and fill depressions formed at the bases, mound and plate area at the end of the game.
7. NO food concessions, alcohol, sales or food shall be sold or given away by the Lessee, nor shall Lessee bring on the premises glass bottles nor any alcoholic beverages of any kind, unless prior written permission is obtained from the Village of Onsted.
8. A designee from the Village of Onsted holds the right to stop activities in the event such activities are detrimental to the overall use of the Park. Failure of Lessee to observe any of these terms and conditions is cause for ejection from the premises at the discretion of the Public Works Manager (or his delegate) and in such case no refund will be made and fines may be charged depending on the circumstances.
9. Decisions regarding the playability of the ball diamonds will be made by the Public Works Department or OCRC president only.
10. Warm-up drills involving batting or pitching balls into the fence are strictly prohibited. Only one team can be on the field when batting or fielding practice is being taken.All warm ups must be conducted on the field of play.
11. The swinging of bats is NOT allowed outside the playing field.
12. Players are NOT to climb or hang on fences.
13. The field is NOT to be tampered with in any way. That means do not add or remove top dressing.
14. The Village of Onsted, its employees, agents, or representatives will not be responsible for any injury, loss, or damage that may occur. TheLessee, on signing this contract, expressly releases the aforementioned from any and all claims, loss, damage or injury.
15. Payment to the Village of Onsted must be paid in full at the time of reservation.
